



New Owner Disclaimer

Please note this is a legal and binding document: Woodland Dogs Ltd will hereafter be referred to as WDL

- I give full permission for my dog/s to be walked off lead whilst in the care of WDL
- I understand that my dog/s will receive the utmost care and attention whilst in the care of WDL
- I fully understand that WDL cannot be held responsible for any injuries that my dog/s may receive, inflict upon any other animal or person or any damage to property. **Please note that a dogs natural way of play is with teeth and claws, minor injuries (including bites, cuts and scratches) swill occur from time to time.**
- We reserve the right to put a muzzle on your dog/s if we feel it is needed for your or other dogs safety.
- WDL will not pay for any vet or other bills that your dog/s may incur in our care but reserve the right to use discretion of payment if we choose.
- All dog/s must be wormed, de-flee and vaccinated regularly, this includes the Kennel Cough Vaccination.
- I agree that my dog/s has received good training and has not shown any signs of aggression towards other dogs, livestock or people and, if my dog/s does show any aggression whilst in the care of WDL, they reserve the right to not walk my dog and cannot be help responsible for any such incident or any cost it may involve.
- All dog/s must have a secure and well fitting collar.
- All dog/s must have an up to date tag with WDL mobile number attached securely to collar
- WDL strongly recommends you have your own insurance to cover any such incidents
- WDL reserves the right to bring your dog/s home early if in the best interest of your dog/s
- WDL will offer various and fair alternatives during extreme weather conditions (ie snow, ice extreme heat) to cover the care of your dog/s, if I choose not to use any then I agree payment will still required from myself
- WDL can with immediate effect give me and my dog/s notice of end of contract.
- I understand fully that WDL requires a 2 week cancellation notice period for end of contract from myself for my dog/s
- I understand that WDL will return via royal mail any property of mine once final payment is made for any monies owing. (collection or delivery will be at WDL discretion)
- I fully understand that WDL cannot be held responsible if my dog strays, is lost or stolen whilst in the care of WDL.
- Bitches will not be allowed to stay or be walked when in season – if your dog/s come into season whilst boarding then WDL reserves the right to put your dog into a reputable kennel of WDL's choice at entirely your cost - no refunds will be given by WDL.
- Bitches will only be walked at least 5 days after bleeding has stopped.

- WDL will not be held responsible for any pregnancies that may occur.
- I fully understand if my dog/s shows any sign of aggression, unsanitary or unsocial behaviour ie excessive barking or continuous soiling WDL reserve the right to place my dog/s into a reputable kennel of their choice at entirely your cost with no refunds given.
- I fully understand that a 50% non-refundable deposit is required at the time of booking your dogs stay via cash or transfer, the balance to be paid at the start of your dog/s stay, no dog will be accepted without full payment or a signed copy of your disclaimer.
- No dogs will be walked without WDL receiving a signed copy of your disclaimer
- ANY NON PAYMENT OF MONIES WILL RESULT IN LEGAL ACTION
